2. Privacy Act 1993 Declaration

In assessing whether to open a credit account in your name, MARAC may exchange information about me / us with credit reporting agencies. MARAC may also use the services of credit reporting agencies on an ongoing basis for purposes relating to the provision of credit to me / us. In relation to using the services of credit reporting agencies for these purposes, MARAC will exchange information about me / us with those agencies, including default information, and the credit reporting agency may give information about me / us, including default information, to its other customers. Credit reporting agencies will hold that information about me / us on their systems and use it to provide their credit reporting services.
